While sometimes we like to make general comments about an individual, we request that you be very detailed. You may include besides their work in the Heroines but other fraternal bodies' activities, their involvement in the community, church, and mentor for new members, mentor for the youth and help seniors, ETC.

You may add anything that will give more credibility to strengthen the Resume of your submission.
